Special Education Data

2020-2021 Transitions and Re-evaluations:

- 17 Students transitioned from Private to Public
 - o 4 additional students chose Homeschooling
- 30 Students transitioned from Public to Private
 - 20 had IEPs transitioned to Service Plans
 - 10 have needs outside of the array
- 38 Re-evaluations
 - 14 Students dismissed

2020-2021 Initial Evaluations:


- 38* Total

The purpose of the SSIT is to collaboratively problem solve to address the needs of individual students who are not making expected progress.















6. Is your building clear about how to make a referral for a special education evaluation?





8th Grade Transitioning: IDEA-Eligible Students

- We will assist with the transition from Private and Parochial Schools to MMSD High Schools
- Important to have 8th grade transition information as soon as possible, so we can assist with the transition process
- Transition Planning in High Schools starts earlier than you would think, typically in November/December
 - o Our team sends letters sent to families in November
- For all students: 9th Grade on Track (9OT) is a process of systematic supports we have implemented in our four comprehensive high schools in MMSD. Provides supports to students and creates smaller learning communities. We have seen great success with the 9OT process.

CLC Funding Cycles

- Competitive application process
- ► Funding for five years, then must reapply
- Average Daily Attendance (ADA) Funding Tier
 - **▶** 25-40 \$80,000
 - **▶** 41-55 \$100,000
 - ▶ 56-70 \$115,000
 - ▶ 71-85 \$130,000
 - ► 86 & Up \$145,000 (MAX)

CLC Grant Requirements

Must Offer:

- ► Academic enrichment opportunities for students
- Additional student activities that complement academic programming
- Opportunities for active and meaningful engagement in each child's education for families

Programs should:

- ► Target students with greatest need
- ► Employ multiple methods for recruiting students
- ► Develop plan for retention of students

MSCR CLC Response To COVID Closure

- ► Elementary CLC sites
 - Supplemented MSCR Cares program with "after school" <u>enrichment clubs</u> held in-person, but led virtually by community partners.
 - Launched MSCR Virtual Enrichment website to give all students access to asynchronous clubs
 - 567 in-person & 64 virtual CLC participants in 20-21.
- ► Secondary CLC sites
 - Shifted to virtual club model
 - Example of Virtual Club Schedule (Wright MS)
 - 696 virtual CLC participants in 20-21.

ESSA Equitable Shares Calculations

If participating per the Affirmation:

Title I allocation for services = # Low Income Students X Per Pupil Amount*

Title II allocation = Total Enrollment X Per Pupil Amount*

Title III allocation for services = Title III Enrollment X Per Pupil Amount*

Title IV allocation = Total Enrollment X Per Pupil Amount*

GEER / ESSER 20-21 allocation = Total Enrollment X Per Pupil Amount*

*Per Pupil Amount = Total award / (public enrollment + private enrollment)

Review of Title I Services 2020-21

All students received virtual instruction

- Strengths
 - No travel time
 - Able to see same number of students
 - Working 1:1
- Challenges
 - Connectivity during the beginning of the year
 - Books were not sent home with students
 - Keeping up with school virtual vs in-person schedules
- Summer materials (parent Involvement) will be delivered to schools for served students to take home

We do not yet know what services will look like for 21-22

Title II, Part A

Review of Title II Services:

- Struggled with meeting requests in a timely manner
- Mid year shift to online request form due to virtual work

Friendly Reminders:

- TII PD reimbursements due June 30th (from an approved request)
- Requests for 2021-22 will begin on July 1 pending:
 - Needs assessment information
 - Allocations



New for 2021-22 Title II-A

- Continue with online request process
- Registration and travel arrangements will be completed by **MMSD**
 - Teachers will provide all registration information
 - If teacher cancels and funds can not be reimbursed, the amount is still deducted from your allocation
 - Meals and other expenses will still be reimbursed (up to allowed amount) after the event with all required itemized receipts.
 - Requests need to be received 4 weeks in advance of event - longer if travel arrangements are necessary.
- Coursework will still follow reimbursement process. However reimbursement will happen immediately vs upon completion of the class

ACCESS Score Reminders

- Students are reclassified at a level 5 on ACCESS
- Changes to cut scores as a part of a standards setting process occurred in 2017 (drop in scores at higher proficiency levels)
- In response to college and career readiness standards
- Speaking expectations increased the most, followed by Reading and Writing. Impact on the Listening domain was minimal
- Information from WIDA available for schools and families (delay with results due to the window)

Title III End of Year Timeline



- Paper results are not expected to arrive in the district until late summer due to the shift in the window
- P/P schools will disseminate ACCESS 2021 results to parents (US mail, enrollment, etc.)
- MMSD will share digital (electronic) test results for ACCESS 2021 via email (with school principal or school secretary)
- K-models or Screener Online for incoming new students will occur in the fall

Title III 2021-22 Tentative Timeline



In Progress - Revised ACCESS window closes on May 21. Universal online short app for parents of new students to answer for the Home Language Survey questions to ensure we are screening only potential ELs.

August - EL Rosters will be sent to PP schools. Please add new students and delete transferred students in this roster while also indicating where they move to (if known). This promotes dual record quality control. Thanks!

September - PP schools must have their EL Rosters updated so that all new students can be given the K-Model or online WIDA Screener by the 3rd Friday count deadline.

Fall Semester - Online WIDA Screener and ACCESS 2.0 trainings are available.

December - February - ACCESS 2022 testing window (Specific Dates TBD) - Paper option to allow us to utilize the entire test window.
